#### **Rules & Regulations**

Welcome to Sparrow Dance Company! We hope you had a great summer break and are ready for an exciting dance year. We have lots of exciting things planned for our dancers and can't wait to get started. In order to make the most of our dance year, we ask that you throroughly review the policies in place at SDC.

#### **Payments & Fees**

- We will be collecting a sign-up fee of \$115. This is an annual, non-refundable fee per an immediate family that includes registration fees, recital fees, insurance fees and video fees. This fee also serves the purpose of saving your child's spot in their class.
- Tuition for your child's class(es) are due no later than the second class week of the month. A late fee will be included after this time. Late fees are \$15 per a child, per a class and will compound upon each other if multiple monthly payments are late. There will be no monthly reminder of tuition, but late fee notices will be sent home with students if parents have not already contacted staff. Tuition fees are non-refundable after the first class of the month. Tuition will not be pro-rated for classes students are not able to attend, or for classes cancelled by staff due to illness or bad weather days. We have pre-scheduled make-up days into our calendar in May and June that will be announced at a later date. If a student wishes to drop a class, staff must be notified. If staff is not notified, tuition is expected to continue.
- Costume payments will be split in half and paid along with tuition in September/October. Costumes fees are non-refundable after costumes are ordered or if tuition is not up to date at the time of a cancelled class notice.
- Any student wishing to be considered for scholarship, partial scholarship, or payment plans must complete a Assistance form prior to recieving scholarship or payment plan options.
- All checks must be made payable to Sparrow Dance Company.

#### Attendance & Class Rules

- In order to serve our students the highest quality classes possible, it is important your child regularly attends their class(es). Please be responsible to make sure your student arrives to class with plenty of time to stretch and/or change clothes. If a class or event is unable to be attended, please let staff know as soon as possible.
- Please be aware that a class must have a minimum number of students to remain on the schedule. If at any regularly scheduled class, less than 50% of students are present, class may be shortened to a small group or private lesson length for the day. If class enrollments are below a pre-determined number, class period may be shortened permanently.
- If a student routinely misses a class and is not excused by a teacher, SDC reserves the right to remove them permanently from the class and class routines to provide a better learning experience for other dancers.
- Classes will routinely let out 1-3 minutes early in order to allow a smooth transition between classes, time for notes, and time for the front desk to be attended to.
- ???We are currently planning our show for June 1st or June 8th with rehearsals the week prior. Recital date depends on auditorium availability and information will be released as soon as it is available. Please mark these

dates on your calendar now so as not to create conflicts later in the year. It is of the upmost importance that our full class perform in our end of year shows as to not hinder our students.

- Christmas performances will only apply to classes included in the winter show classes. These shows will take place the beginning of December and all costumes are parent provided unless otherwise noted. Please let us know if you have a conflict with these in a timely manner
- All students are eligible to take part in our Christmas parade float. All costumes are parent provided unless otherwise noted.
- Please make sure your student is in SDC dress code throughout the year in order to ensure each student is safe, modest, and thoroughly equipped for full participation.
